UNANIMOUS CONSENT AGREEMENT

H.R. 2560 (ORDER NO. 106)

Ordered, That, on Thursday, July 21, 2011, when the Senate considers the motion to proceed to H.R. 2560, an Act to cut, cap, and balance the Federal budget, the time until 2:00 p.m. be equally divided and controlled by the two Leaders or their designees, with Senators permitted to speak therein for a period of up to 10 minutes each, with the Republicans controlling the first 30 minutes and the Majority controlling the next 30 minutes. *(July 20, 2011.)*
