**UNANIMOUS CONSENT AGREEMENTS**

## S. 3525 (ORDER NO. 504)

1.—*Ordered*, That at 5:30 p.m. on Tuesday, November 13, 2012, all post-cloture time on the motion to proceed to S. 3525, a bill to protect and enhance opportunities for recreational hunting, fishing, and shooting, and for other purposes, be yielded back and the Senate proceed to vote on the motion to proceed. (*Sept. 22, 2012.*)

## S. 3414 (ORDER NO. 470)

2.—*Ordered*, That with respect to the motion to invoke cloture on S. 3414, a bill to enhance the security and resiliency of the cyber and communications infrastructure of the United States, the mandatory quorum required under Rule XXII be waived.

*Ordered further*, That the filing deadline for second degree amendments to S. 3414 be at 10:00 a.m. on Thursday, August 2, 2012. (*July 31, Aug. 1, 2012.*)

## S. 3220 (ORDER NO. 410)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 3220, a bill to amend the Fair Labor Standards Act of 1938 to provide more effective remedies to victims of discrimination in the payment of wages on the basis of sex, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*May 24, 2012.*)
