## S. 1243 (ORDER NO. 99)

1.—*Ordered*, That at 4:15 p.m. on Monday, July 29, 2013, the Senate resume consideration of S. 1243, an original bill making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2014, and for other purposes; provided, that the text of H.R. 2610, as reported by the House Appropriations Committee, be deemed House-passed text for the purposes of Rule XVI. (*July 18, 25, 2013.*)

## S. 1238 (ORDER NO. 124)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1238, a bill to amend the Higher Education Act of 1965 to extend the current reduced interest rate for undergraduate Federal Direct Stafford Loans for 1 year, to modify required distribution rules for pension plans, and for other purposes; provided, that the mandatory quorum required under Rule XXII be waived. (*July 8, 2013.*)
