1.—Ordered, That at 12:00 noon on Thursday, January 9, 2014, all post-cloture time be considered expired with respect to the motion to proceed to S. 1845, a bill to provide for the extension of certain unemployment benefits, and for other purposes. (Jan. 8, 2014.)

S. 1197 (ORDER NO. 91)

2.—Ordered, That with respect to the cloture motion on S. 1197, an original bill to authorize appropriations for fiscal year 2014 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the mandatory quorum required under Rule XXII be waived.

Res. 8 an original concurrent resolution setting forth the congressional budget for the United States Government for fiscal year 2014, revising the appropriate budgetary levels for fiscal year 2013, and setting forth the appropriate budgetary levels for fiscal years 2015 through 2023, the conferees on the part of the Senate are instructed to report back a conference report by December 13, 2013.

Ordered further, That it not be in order for the Senate to consider a conference report with respect to H. Con. Res. 25 or S. Con. Res. 8 if it includes reconciliation instructions to raise the debt limit. (Oct. 16, 2013.)


