UNANIMOUS CONSENT AGREEMENT

H.R. 203 (ORDER NO. 6)

Ordered, That on Monday, February 2, 2015, at 4:30 p.m., the Senate proceed to the consideration of H.R. 203, an act to direct the Secretary of Veterans Affairs to provide for the conduct of annual evaluations of mental health care and suicide prevention programs of the Department of Veterans Affairs, to require a pilot program on loan repayment for psychiatrists who agree to serve in the Veterans Health Administration of the Department of Veterans Affairs, and for other purposes; provided, that the time until 5:30 p.m. be equally divided in the usual form: provided further, that following the use or yielding back of time, the bill be read a third time and the Senate vote on passage of the bill, without any intervening action or debate. (*Jan. 29, 2015.*)
