UNANIMOUS CONSENT AGREEMENTS

H.R. 203 (ORDER NO. 6)

1.—*Ordered*, That on Tuesday, February 3, 2015, upon the conclusion of Morning Business, the Senate proceed to the consideration of H.R. 203, an act to direct the Secretary of Veterans Affairs to provide for the conduct of annual evaluations of mental health care and suicide prevention programs of the Department of Veterans Affairs, to require a pilot program on loan repayment for psychiatrists who agree to serve in the Veterans Health Administration of the Department of Veterans Affairs, and for other purposes; provided, that the time until 12:00 noon be equally divided in the usual form; provided further, that following the use or yielding back of time, the bill be read a third time and the Senate vote on passage of the bill, without any intervening action or debate. (*Jan. 29, Feb. 2, 2015.*)

H.R. 240 (ORDER NO. 5)

2.—*Ordered*, That on Tuesday, February 3, 2015, at 2:30 p.m., the Senate vote on the motion to invoke cloture on the motion to proceed to H.R. 240, an act making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2015, and for other purposes; provided, that if the motion to invoke cloture on the motion to proceed is agreed to, all post-cloture time be yielded back and the Senate proceed to vote on the motion to proceed; provided further, that with respect to the motion to invoke cloture on the motion to proceed, the mandatory quorum required under Rule XXII be waived. (*Jan. 30, 2015.*)
