H.R. 240 (ORDER NO. 5)

Ordered, That on Thursday, February 5, 2015, upon the conclusion of Leader remarks, the Senate resume consideration of the motion to proceed to H.R. 240, an act making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2015, and for other purposes; provided, that the time until 11:30 a.m. be equally divided in the usual form; provided further, that with respect to the motion to invoke cloture on the motion to proceed, the mandatory quorum required under Rule XXII be waived.
