UNANIMOUS CONSENT AGREEMENTS

S. 178 (ORDER NO. 26)

1.—*Ordered*, That following Leader remarks on Tuesday, March 17, 2015, the Senate resume consideration of S. 178, a bill to provide justice for the victims of trafficking.

Ordered further, That the filing deadline for first degree amendments be 5:00 p.m. on Monday, March 16, 2015 and the filing deadline for second degree amendments be 10:30 a.m. on Tuesday, March 17, 2015; provided, that with respect to the motions to invoke cloture on S. 178, the mandatory quorum required under Rule XXII be waived. (*Mar. 12, 16, 2015.*)

S. 534 (ORDER NO. 22)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
