UNANIMOUS CONSENT AGREEMENTS**H.R. 1314 (ORDER NO. 58)**

1.—*Ordered*, That, notwithstanding the provisions of Rule XXII of the Standing Rules of the Senate, at 2:30 p.m. on Tuesday, May 12, 2015, the Senate vote on the motion to invoke cloture on the motion to proceed to H.R. 1314, an Act to amend the Internal Revenue Code of 1986 to provide for a right to an administrative appeal relating to adverse determinations of tax-exempt status of certain organizations; provided, that the mandatory quorum call under Rule XXII be waived. (*May 7, 11, 2015.*)

S. 534 (ORDER NO. 22)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
