UNANIMOUS CONSENT AGREEMENTS

H.R. 1314 (ORDER NO. 58)

1.—*Ordered*, That following Leader Remarks on Friday, May 22, 2015, the Senate resume consideration of H.R. 1314, an Act to amend the Internal Revenue Code of 1986 to provide for a right to an administrative appeal relating to adverse determinations of tax-exempt status of certain organizations; provided, that all time during the adjournment of the Senate count post-cloture. (*May 21, 2015.*)

S. 534 (ORDER NO. 22)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
