PENDING BUSINESS

H.J. RES. 61 (ORDER NO. 170)

A joint resolution amending the Internal Revenue Code of 1986 to exempt employees with health coverage under TRICARE or the Veterans Administration from being taken into account for purposes of determining the employers to which the employer mandate applies under the Patient Protection and Affordable Care Act. (Sept. 8, 2015.)

UNANIMOUS CONSENT AGREEMENTS

H.R. 1735 (ORDER NO. 99)

1.—Ordered, That following Leader remarks on Wednesday, October 7, 2015, the Senate resume consideration of the Conference Report to Accompany H.R. 1735, an act to authorize appropriations for fiscal year 2016 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes; provided, that the time until 1:00 p.m. be equally divided between the two Leaders or their designees; provided further, that the time from 1:00 p.m. until 1:30 p.m. be controlled by the Democratic manager or his designee, and the time from 1:30 p.m. until 2:00 p.m. be controlled by the Chairman of the Committee on Armed Services or his designee; further, that notwithstanding the provisions of Rule XXII, all post-cloture time on the Conference Report be deemed expired at 2:00 p.m. (Oct. 6, 2015.)

H.R. 2028 (ORDER NO. 96)

2.—Ordered, That with respect to the cloture motion to proceed to H.R. 2028, an act making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (Oct. 6, 2015.)

H.R. 2029 (ORDER NO. 98)

3.—Ordered, That with respect to the cloture motion on the motion to proceed to H.R. 2029, an act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (Sept. 30, 2015.)

S. 754 (ORDER NO. 28)

4.—Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to the consideration of S. 754, a bill to improve cybersecurity in the United States through enhanced sharing of information about cybersecurity threats, and for other purposes; provided, that the Senator from North Carolina (Mr. Burr) be recognized to offer the Burr/Feinstein substitute amendment; provided further, that it be in order for the Majority bill manager or his designees to offer up to 10 first degree amendments relevant to the subject matter and for the Democratic bill manager or her designees to offer up to 11 first degree amendments relevant to the subject matter. (Aug. 5, 2015.)

S. 1881 (ORDER NO. 169)

5.—Ordered, That with respect to the cloture motion on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (Aug. 3, 2015.)

S. 1357 (ORDER NO. 86)

6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

S. 534 (ORDER NO. 22)

7.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (Feb. 27, 2015.)
