UNANIMOUS CONSENT AGREEMENTS

S. 2146 (ORDER NO. 252)

1.—Ordered, That following Leader remarks on Monday, October 19, 2015, the Senate resume consideration of the motion to proceed to S. 2146, a bill to hold sanctuary jurisdictions accountable for defying Federal law, to increase penalties for individuals who illegally reenter the United States after being removed, and to provide liability protection for State and local law enforcement who cooperate with Federal law enforcement, and for other purposes; provided, that notwithstanding the provisions of Rule XXII, on Tuesday, October 20, 2015, at 2:15 p.m., the Senate vote on the motion to invoke cloture on the motion to proceed to S. 2146; provided further, that with respect to the cloture motion, the mandatory quorum under Rule XXII be waived. (Oct. 8, 2015.)

H.R. 2029 (ORDER NO. 98)

2.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 2029, an act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (Sept. 30, 2015.)

S. 754 (ORDER NO. 28)

3.—Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to the consideration of S. 754, a bill to improve cybersecurity in the United States through enhanced sharing of information about cybersecurity threats, and for other purposes; provided, that the Senator from North Carolina (Mr. Burr) be recognized to offer the Burr/Feinstein substitute amendment; provided further, that it be in order for the Majority bill manager or his designees to offer up to 10 first degree amendments relevant to the subject matter and for the Democratic bill manager or her designees to offer up to 11 first degree amendments relevant to the subject matter. (Aug. 5, 2015.)

S. 1881 (ORDER NO. 169)

4.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (Aug. 3, 2015.)

S. 1357 (ORDER NO. 86)

5.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

S. 534 (ORDER NO. 22)

6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (Feb. 27, 2015.)
