H.J. RES. 61 (ORDER NO. 170)

A joint resolution amending the Internal Revenue Code of 1986 to exempt employees with health coverage under TRICARE or the Veterans Administration from being taken into account for purposes of determining the employers to which the employer mandate applies under the Patient Protection and Affordable Care Act. (*Sept. 8, 2015.*)

UNANIMOUS CONSENT AGREEMENTS

S. 1140 (ORDER NO. 153)

1.—*Ordered*, That following Leader Remarks on Tuesday, November 3, 2015, the Senate resume consideration of the motion to proceed to S. 1140, a bill to require the Secretary of the Army and the Administrator of the Environmental Protection Agency to propose a regulation revising the definition of the term “waters of the United States”, and for other purposes; provided, that the time until 12:30 p.m. be equally divided between the two Leaders or their designees and the time from 2:15 p.m. until 2:30 p.m. be equally divided in the usual form; provided further, that notwithstanding the provisions of Rule XXII, the Senate vote on the motion to invoke cloture on the motion to proceed to S. 1140 at 2:30 p.m. (*Oct. 30, 2015.*)

H.R. 2029 (ORDER NO. 98)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 2029, an act making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Sept. 30, 2015.*)

S. 1881 (ORDER NO. 169)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

S. 1357 (ORDER NO. 86)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

S. 534 (ORDER NO. 22)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
