CONFERENCE REPORT TO ACCOMPANY S. 1177

1.—Ordered, That following Leader Remarks on Wednesday, December 9, 2015, the Senate resume consideration of the conference report to accompnay S. 1177, an original bill to reauthorize the Elementary and Secondary Education Act of 1965 to ensure that every child achieves; provided, that, the time until 10:45 a.m. be equally divided between the two Leaders or their designees; provided further, that notwithstanding Rule XXII, at 10:45 a.m., the Senate vote on adoption of the conference report. 4.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

S. 534 (ORDER NO. 22)

5.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived.
