**UNANIMOUS CONSENT AGREEMENTS**

H.R. 4038 (ORDER NO. 300)

1.—*Ordered*, That at 2:15 p.m. on Wednesday, January 20, 2016, the Senate resume consideration of the motion to proceed to H.R. 4038, an act to require that supplemental certifications and background investigations be completed prior to the admission of certain aliens as refugees, and for other purposes; provided, that the time until 2:30 p.m. be equally divided between the two Leaders or their designees; provided further, that, notwithstanding Rule XXII, at 2:30 p.m., the Senate vote on the motion to invoke cloture on the motion to proceed to H.R. 4038; further, that if cloture is invoked, then the post-cloture time be counted as if cloture had been invoked at 6:00 p.m. on Tuesday, January 19, 2016; further, that with respect to the cloture motion, the mandatory quorum under Rule XXII be waived. (*Jan. 12, 19, 2016.*)

H.R. 2685 (ORDER NO. 118)

2.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Nov. 3, 2015.*)

S. 1881 (ORDER NO. 169)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

S. 1357 (ORDER NO. 86)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

S. 534 (ORDER NO. 22)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
