#### PENDING BUSINESS

#### H.R. 2577 (ORDER NO. 138)

An act making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2016, and for other purposes. (Nov. 18, 2015.)

#### UNANIMOUS CONSENT AGREEMENTS

#### S. 2012 (ORDER NO. 218)

1.—Ordered, That upon the conclusion of Morning Business on Tuesday, February 2, 2016, the Senate resume consideration of S. 2012, a bill to provide for the modernization of the energy policy of the United States, and for other purposes; provided, that it be in order to call up the following admendments:

—Lee Amdt. No. 3023;

—Franken Amdt. No. 3115.

Ordered further, That the time between 2:15 p.m. and 2:30 p.m. be equally divided in the usual form; provided, that at 2:30 p.m., the Senate vote in relation to the above amendments in the order listed; provided further, that there be 2 minutes of debate equally divided prior to each vote; further, that no second degree amendments be in order prior to the votes and that a 60 vote affirmative threshold be required for adoption. (Feb. 1, 2016.)

#### H.R. 2685 (ORDER NO. 118)

2.—Ordered, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (Nov. 3, 2015.)

#### S. 1881 (ORDER NO. 169)

3.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (Aug. 3, 2015.)

#### S. 1357 (ORDER NO. 86)

4.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

#### S. 534 (ORDER NO. 22)

5.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (Feb. 27, 2015.)
