#### PENDING BUSINESS

#### H.R. 2577 (ORDER NO. 138)

An act making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2016, and for other purposes. (*Nov. 18, 2015.*)

#### UNANIMOUS CONSENT AGREEMENTS

#### S. 2012 (ORDER NO. 218)

1.—Ordered, That with respect to the motions to invoke cloture on Amdt. No. 2953, offered by the Senator from Alaska (Ms. Murkowski), and S. 2012, a bill to provide for the modernization of the energy policy of the United States, and for other purposes, the mandatory quorum under Rule XXII be waived; provided, that the filing deadline for all first degree amendments to Amdt. No. 2953 and S. 2012 be at 1:00 p.m. on Wednesday, February 3, 2016. (Feb. 2, 2016.)

#### H.R. 757 (ORDER NO. 359)

2.—Ordered, That upon the conclusion of Morning Business on Wednesday, February 10, 2016, the Senate proceed to the consideration of H.R. 757, an Act to improve the enforcement of sanctions against the Government of North Korea, and for other purposes; provided, that there be up to 7 hours of debate equally divided in the usual form; provided further, that following the use or yielding back of that time, the committee reported amendment be agreed to, the bill, as amended, be read a third time, and the Senate vote on the bill with no intervening action or debate. (Feb. 3, 2016.)

#### H.R. 2685 (ORDER NO. 118)

3.—Ordered, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (Nov. 3, 2015.)

#### S. 1881 (ORDER NO. 169)

4.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (Aug. 3, 2015.)

### S. 1357 (ORDER NO. 86)

5.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

#### S. 534 (ORDER NO. 22)

6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (Feb. 27, 2015.)
