UNANIMOUS CONSENT AGREEMENTS

S. 524 (ORDER NO. 369)

1.—Ordered, That at 5:00 p.m. on Monday, February 29, 2016, the Senate resume consideration of the motion to proceed to S. 524, a bill to authorize the Attorney General to award grants to address the national epidemics of prescription opioid abuse and heroin use; provided, that the time until 5:30 p.m. be equally divided between the two managers or their designees; provided further, that notwithstanding Rule XXII, at 5:30 p.m., the Senate vote on the motion to invoke cloture on the motion to proceed; further, that with respect to the motion to invoke cloture on the motion to proceed, the mandatory quorum under Rule XXII be waived. (Feb. 25, 2016.)

S. 2012 (ORDER NO. 218)

2.—Ordered, That with respect to the motions to invoke cloture on Amdt. No. 2953, offered by the Senator from Alaska (Ms. Murkowski), and S. 2012, a bill to provide for the modernization of the energy policy of the United States, and for other purposes, the mandatory quorum under Rule XXII be waived; provided, that the filing deadline for all first degree amendments to Amdt. 5.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

S. 534 (ORDER NO. 22)

6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived.
