UNANIMOUS CONSENT AGREEMENTS

S. 2012 (ORDER NO. 218)

1.—Ordered, That following Leader Remarks on Wednesday, April 20, 2016, the Senate resume consideration of S. 2012, a bill to provide for the modernization of the energy policy of the United States, and for other purposes, as amended; provided, that the time until 10:00 a.m. be equally divided between the two Leaders or their designees; provided further, that at 10:00 a.m., the Senate vote on passage of S. 2012, as amended; further, that budget points of order not be barred by virtue of this agreement. (Apr. 13, 19, 2016.)

H.R. 2028 (ORDER NO. 96)

2.—Ordered, That following the disposition of S. 2012, as amended, if amended, but not prior to Wednesday, April 20, 2016, the motion to invoke cloture on the motion to proceed to H.R. 2028, an Act making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2016, and for other purposes, be withdrawn and the Senate proceed to the consideration of H.R. 2028; provided, that with respect to the motion to invoke cloture on the motion to proceed to H.R. 2028, Friday, April 15, 2016 count as the intervening day and the mandatory quorum under Rule XXII be waived. (Apr. 14, 18, 2016.)

HOUSE MESSAGE TO ACCOMPANY S. 764

3.—Ordered, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 3450, offered by the Senator from Kentucky (Mr. McConnell), the mandatory quorum required under Rule XXII be waived. (Mar. 14, 2016.)

H.R. 2685 (ORDER NO. 118)

4.—Ordered, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (Nov. 3, 2015.)

S. 1881 (ORDER NO. 169)

5.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (Aug. 3, 2015.)

S. 1357 (ORDER NO. 86)

6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

S. 534 (ORDER NO. 22)

7.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (Feb. 27, 2015.)
