UNANIMOUS CONSENT AGREEMENTS

H.R. 2028 (ORDER NO. 96)

1.—*Ordered*, That upon the conclusion of Morning Business on Thursday, April 21, 2016, the Senate resume consideration of H.R. 2028, an Act making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2016, and for other purposes; provided, that at 11:45 a.m., the Senate vote on Amdt. No. 3811, offered by the Senator from Tennessee (Mr. Alexander) for the Senator from North Dakota (Mr. Hoeven), and that it be subject to a 60 affirmative vote threshold for adoption; provided further, that no second degree amendments be in order prior to the vote; further, that Amdt. No. 3801, offered by the Senator from Tennessee (Mr. Alexander), be considered a committee-reported substitute. (*Apr. 20, 2016.*)

HOUSE MESSAGE TO ACCOMPANY S. 764

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 3450, offered by the Senator from Kentucky (Mr. McConnell), the mandatory quorum required under Rule XXII be waived. (*Mar. 14, 2016.*)

H.R. 2685 (ORDER NO. 118)

3.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Nov. 3, 2015.*)

S. 1881 (ORDER NO. 169)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

S. 1357 (ORDER NO. 86)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

S. 534 (ORDER NO. 22)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
