UNANIMOUS CONSENT AGREEMENTS

H.R. 2577 (ORDER NO. 138)

1.—Ordered, That upon the conclusion of Morning Business on Wednesday, May 18, 2016, the Senate resume consideration of H.R. 2577, an Act making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2016, and for other purposes; provided, that all time during the adjournment and Morning Business count post-cloture on Amdt. No. 3900, offered by the Senator from Kentucky (Mr. McConnell).

Ordered further, That Amdt. 3896, offered by the Senator from Maine (Ms. Collins), be considered a committee reported substitute from the Senator Committee on the Appropria

Ordered further, That Amdt. 3896, offered by the Senator from Maine (Ms. Collins), be considered a committee-reported substitute from the Senate Committee on the Appropriations for the purposes of Rule XVI; provided, that H.R. 2577 serve as the basis for defense of germaneness under Rule XVI for the division of Amdt. No. 3896 that contains S. 2844; provided further, that H.R. 4974, as reported by the House Committee on Appropriations, serve as the basis for defense of germaneness under Rule XVI for the division of Amdt. No. 3896 that contains S. 2806; further, that floor amendments be drafted to one of the two divisions and its corresponding House text be used for defense of germaneness and that Rule XVI discipline apply during consideration of this measure.

Ordered further, That with respect to the motions to invoke cloture on Amdt. No. 3896 and H.R. 2577, the mandatory quorums under Rule XXII be waived. (May 12, 17, 2016)

(May 23, 2015.)

S. 534 (ORDER NO. 22)
