UNANIMOUS CONSENT AGREEMENTS

S. 2943 (ORDER NO. 469)

1.—Ordered, That following Leader remarks on Friday, June 10, 2016, the Senate resume consideration of S. 2943, a bill to authorize appropriations for fiscal year 2017 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes; provided, that, notwithstanding Rule XXII, at 9:00 a.m., the Senate vote on the motion to invoke cloture; provided further, that the filing deadline for second degree amendments to S. 2943 be at 8:45 a.m. on Friday, June 10, 2016; further, that with respect to the motion to invoke cloture on S. 2943, as amended, the mandatory quorum under Rule XXII be waived (June 8, 9, 2016.)

H.R. 2578 (ORDER NO. 120)

2.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 2578, an Act making appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (June 9, 2016.)

3.—Ordered, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 3450, offered by the Senator from Kentucky (Mr. McConnell), the mandatory quorum required under Rule XXII be waived. (Mar. 14, 2016.)

H.R. 2685 (ORDER NO. 118)

(May 23, 2015.)
