UNANIMOUS CONSENT AGREEMENTS

1.—Ordered, That upon the conclusion of Morning Business on Wednesday, June 15, 2016, the Senate vote on the motion to proceed to H.R. 2578, an Act making appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2016, and for other purposes. (June 14, 2016.)

HOUSE MESSAGE TO ACCOMPANY S. 764

2.—Ordered, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 3450, offered by the Senator from Kentucky (Mr. McConnell), the mandatory quorum required under Rule XXII be waived. (Mar. 14, 2016.)

H.R. 2685 (ORDER NO. 118)

(May 23, 2015.)

S. 534 (ORDER NO. 22)

6.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
