UNANIMOUS CONSENT AGREEMENTS

H.R. 2577 (ORDER NO. 138)

1.—*Ordered*, That with respect to the motion to invoke cloture on the Conference Report to Accompany H.R. 2577, an Act making appropriations for the Departments of Transportation, and Housing and Urban Development, and related agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*June 23, 2016.*)

H.R. 2578 (ORDER NO. 120)

2.—*Ordered*, That with respect to the motion to invoke cloture on Amdt. No. 4787, offered by the Senator from Kentucky (Mr. McConnell) for the Senator from Arizona (Mr. McCain), to H.R. 2578, an Act making appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived; provided further, that the filing deadline under Rule XXII be at 2:30 p.m. on Tuesday. H.R. 2685 (ORDER NO. 118)

(*May 23, 2015.*)

S. 534 (ORDER NO. 22)

7.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived.
