#### UNANIMOUS CONSENT AGREEMENTS

## HOUSE MESSAGE TO ACCOMPANY S. 764

1.—Ordered, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 764, a bill to reauthorize and amend the National Sea Grant College Program Act, and for other purposes, with Amdt. No. 4935, offered by the Senator from Kentucky (Mr. McConnell), the cloture motion ripen on Wednesday, July 6, 2016, upon the disposition of the Martinotti nomination and the mandatory quorum under Rule XXII be waived. (June 29, 2016.)

### S. 3100 (ORDER NO. 531)

2.—Ordered, That on Wednesday, July 6, 2016, upon the conclusion of Leader remarks, the Senate resume consideration of the motion to proceed to S. 3100, a bill to ensure that States and local law enforcement may cooperate with Federal officials to protect our communities from violent criminals and suspected terrorists who are illegally present in the United States; provided, that with respect to the cloture motion filed on the motion to proceed, the cloture motion ripen on Wednesday, July 6, 2016, upon the disposition of the Martinotti nomination and the mandatory quorum required under Rule XXII be waived. (June 29, 2016.)

### S. 2193 (ORDER NO. 276)

3.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 2193, a bill to amend the Immigration and Nationality Act to increse penalties for individuals who illegally reenter the United States after being removed and for other purposes, the cloture motion ripen on Wednesday, July 6, 2016, upon the disposition of the Martinotti nomination and that the mandatory quorum required under Rule XXII be waived. (June 29, 2016.)

### H.R. 5293 (ORDER NO. 524)

4.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 5293, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2017, and for other purposes, the cloture motion ripen on Wednesday, July 6, 2016, upon the disposition of the Martinotti nomination and the mandatory quorum required under Rule XXII be waived. (June 29, 2016.)

## H.R. 2578 (ORDER NO. 120)

5.—Ordered, That with respect to the motion to invoke cloture on Amdt. No. 4787, offered by the Senator from Kentucky (Mr. McConnell) for the Senator from Arizona (Mr. McCain), to H.R. 2578, an Act making appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived; provided further, that the filing deadline under Rule XXII be at 2:30 p.m. on Tuesday. (June 20, 2016.)

### H.R. 2685 (ORDER NO. 118)

6.—Ordered, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (Nov. 3, 2015.)

#### S. 1881 (ORDER NO. 169)

7.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (Aug. 3, 2015.)

## S. 1357 (ORDER NO. 86)

8.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (May 23, 2015.)

## S. 534 (ORDER NO. 22)

9.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (Feb. 27, 2015.)
