## UNANIMOUS CONSENT AGREEMENTS

### HOUSE MESSAGE TO ACCOMPANY S. 2943

1.—*Ordered*, That following the prayer and the pledge on Thursday, July 14, 2016, the Chair lay before the Senate the House Message to Accompany S. 2943, a bill to authorize appropriations for fiscal year 2017 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes; provided, that the Senator from Kentucky (Mr. McConnell) be recognized to make a compound motion to go to conference; provided further, that after cloture is filed on the compound motion, the time until 11:30 a.m. be equally divided between the two Leaders or their designees and then at 11:30 a.m., the Senate vote on the motion to invoke cloture on the compound motion to go to conference.

*Ordered further*, That if cloture is invoked, the Senate agree to the compound motion to go to conference and there be two motions to instruct the conferees in order made by the Senator from New Hampshire (Mrs. Shaheen) and the Senator from Alaska (Mr. Sullivan); provided, that the Senator from New Hampshire be recognized to offer a motion to instruct the conferees and that there be up to 4 minutes of debate equally divided on the motion and that following the use or yielding back of that time, the Senate vote in relation to the motion; provided further, that following disposition of the motion to instruct conferees made by the Senator from New Hampshire, the Senator from Alaska be recognized to offer a motion to instruct the conferees and that there be up to 4 minutes of debate equally divided on the motion and that following the use or yielding back of that time, the Senate vote in relation to the motion without any intervening action or debate. (*July 13, 2016.*)

#### H.R. 5293 (ORDER NO. 524)

2.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 5293, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2017, and for other purposes; provided, that with respect to the motion to invoke cloture on the motion to proceed, the mandatory quorum required under Rule XXII be waived. (*June 29, 2016.*)

#### H.R. 2578 (ORDER NO. 120)

3.—*Ordered*, That with respect to the motion to invoke cloture on Amdt. No. 4787, offered by the Senator from Kentucky (Mr. McConnell) for the Senator from Arizona (Mr. McCain), to H.R. 2578, an Act making appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived; provided further, that the filing deadline under Rule XXII be at 2:30 p.m. on Tuesday. (*June 20, 2016.*)

#### H.R. 2685 (ORDER NO. 118)

4.—*Ordered*, That with respect to the cloture motion on the motion to proceed to H.R. 2685, an act making appropriations for the Department of Defense for the fiscal year ending September 30, 2016, and for other purposes, the mandatory quorum under Rule XXII be waived. (*Nov. 3, 2015.*)

#### S. 1881 (ORDER NO. 169)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1881, a bill to prohibit Federal funding of Planned Parenthood Federation of America, the mandatory quorum under Rule XXII be waived. (*Aug. 3, 2015.*)

#### S. 1357 (ORDER NO. 86)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 1357, a bill to extend authority relating to roving surveillance, access to business records, and individual terrorists as agents of foreign powers under the Foreign Intelligence Surveillance Act of 1978 until July 31, 2015, and for other purposes, the mandatory quorum under Rule XXII be waived. (*May 23, 2015.*)

## S. 534 (ORDER NO. 22)

7.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 534, a bill to prohibit funds from being used to carry out certain Executive actions related to immigration, and for other purposes, the mandatory quorum required under Rule XXII be waived. (*Feb. 27, 2015.*)
