1.—Ordered, That with respect to the cloture motion filed on the Conference Report to Accompany H.R. 5515, an Act to authorize appropriations for fiscal year 2019 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the mandatory quorum call under Rule XXII be waived; provided, that the cloture motion ripen at 5:30 p.m. on Monday, July 30, 2018. (July 26, 2018.)

### HOUSE MESSAGE WITH RESPECT TO S. 1182

2.—Ordered, That at 12:15 p.m. on Tuesday, July 31, 2018, the Senate resume consideration of the House Message with respect to S. 1182, an Act to require the Secretary of the Treasury to mint commemorative coins in recognition of the 100th anniversary of The American Legion; provided, that notwithstanding Rule XXII the cloture motion, the motion to refer and the motion to concur with amendment be withdrawn and the Senate vote on the motion to concur without further intervening action or debate. No. 3399, and that H.R. 6072, as reported by the House appropriations committee, serve as the basis for defense of germaneness for Division D of Amdt. No. 3399; provided, that notwithstanding Rule XXII the filing deadline for first degree amendments be at 4:00 p.m. on Monday, July 30, 2018; provided further, that with respect to the cloture motions the mandatory quorum call under Rule XXII be waived; further, that the cloture motions ripen at 5:30 p.m. on Monday, July 30, 2018.

Ordered further, That following the disposition of the Grant nomination, there be 5 minutes of debate, equally divided in the usual form, prior to the cloture vote on Amdt. No. 3399. (July 23, 26, 30, 2018.)


