UNANIMOUS CONSENT AGREEMENTS

H.R. 6157 (Order No. 500)

1.—*Ordered*, That following disposition of the Richardson nomination, the Senate proceed to Legislative Session and the consideration of H.R. 6157, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2019, and for other purposes; provided, that for the purpose of Rule XVI in relation to the substitute Amdt. No. 3695, the text of H.R. 6157 serve as the basis for defense germaneness for Division A of the amendment and the text of H.R. 6470, as reported by the House appropriations committee, serve as the basis for defense of germaneness of Division B of the amendment. (*Aug. 15, 2018.*)

HOUSE MESSAGE TO ACCOMPANY S. 140

2.—*Ordered*, That with respect to the cloture motion filed on the motion to concur with a further amendment in the House Amendment to S. 140, an Act to amend the White Mountain Apache Tribe Water Rights Quantification Act of 2010 to clarify the use of amounts in the WMAT Settlement Fund, the mandatory quorum call under Rule XXII be waived. (*Apr. 16, 2018.*)
