
UNANIMOUS CONSENT AGREEMENTS

H.R. 6157 (ORDER NO. 500)

1.—Ordered, That on Wednesday, August 22, 2018, following Leader remarks, the Senate resume consideration of H.R. 6157, an Act making appropriations for the Department of Defense for the fiscal year ending September 30, 2019, and for other purposes; provided, that for the purpose of Rule XVI in relation to the substitute Amdt. No. 3695, the text of H.R. 6157 serve as the basis for defense of germaneness for Division A of the amendment and the text of H.R. 6470, as reported by the House appropriations committee, serve as the basis for defense of germaneness of Division B of the amendment; provided further, that with respect to the cloture motions filed on the bill and substitute amendment, the mandatory quorum calls under Rule XXII be waived. 
