#### UNANIMOUS CONSENT AGREEMENTS

#### S. 2554 (ORDER NO. 549)


1.—Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to the consideration of S. 2554, to ensure that health insurance issuers and group health plans do not prohibit pharmacy providers from providing certain information to enrollees; provided, that the Senator from Utah (Mr. Lee), or his designee, be recognized to call up Amdt. No. 4011 and that there be up to one hour of debate, equally divided on the amendment, and that upon the use or yielding back of time, the Senate vote on Amdt. No. 4011 without intervening action or debate; provided further, that upon disposition of Amdt. No. 4011, the bill be read a third time and the Senate vote on passage of the bill as amended, if amended. (Sept. 6, 2018.)

#### H.R. 6 (ORDER NO. 485)

2.—Ordered, That at a time to be determined by the Majority Leader in consultation with the Democratic Leader, the Senate proceed to the consideration of H.R. 6, an Act to provide for opioid use disorder prevention, recovery, and treatment, and for other purposes; provided, that the Senator from Tennessee (Mr. Alexander), or his designee, be recognized to call up Amdt. No. 4013; provided further, that there be one hour of debate, equally divided; further, that upon the use or yielding back of time, Amdt. No. 4013 be agreed to, H.R. 6, as amended, be read a third time, and the Senate vote on the bill, as amended, without intervening action or debate. (Sept. 6, 2018.)


3.—Ordered, That with respect to the cloture motion filed on the motion to concur with a further amendment in the House Amendment to S. 140, an Act to amend the White Mountain Apache Tribe Water Rights Quantification Act of 2010 to clarify the use of amounts in the WMAT Settlement Fund, the mandatory quorum call under Rule XXII be waived. (Apr. 16, 2018.)
