

S.J. RES. 64 (ORDER NO. 630)



Res. 64, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Department of the Treasury relating to "Returns by Exempt Organizations and Returns by Certain Non-Exempt Organizations", the period for consideration under The Congressional Review Act be extended until December 14, 2018.
