2022 H.R. 7174 June 21	A bill to amend the Homeland Security Act of 2002 to reauthorize the National Computer Forensics Institute of the United States Secret Service, and for other purposes. (Pending is the vote on the motion to suspend the rules and pass, as amended.)
H.R. 5274 June 21	A bill to amend the Homeland Security Act of 2002 to provide training for U.S. Customs and Border Protection personnel on the use of containment devices to prevent secondary exposure to fentanyl and other potentially lethal substances, and for other purposes. (Pending is the vote on the motion to suspend the rules and pass.)
H.R. 1934 June 21	A bill to direct the Federal Government to provide assistance and technical expertise to enhance the representation and leadership of the United States at international standards-setting bodies that set standards for equipment, systems, software, and virtually defined networks that support 5th and future generations mobile telecommunications systems and infrastructure, and for other purposes. (Pending is the vote on the motion to suspend the rules and pass, as amended.)
H. Con. Res. 59 June 21	A resolution condemning the October 25, 2021, military coup in Sudan and standing with the people of Sudan. (Pending is the vote on the motion to suspend the rules and agree.)
H. Res. 720 June 21	A resolution calling for stability and the cessation of violence and condemning ISIS-affiliated terrorist activity in northern Mozambique, including the Cabo Delgado Province, and for other purposes. (Pending is the vote on the motion to suspend the rules and agree.)
H. Con. Res. 45 June 21	A resolution expressing the sense of Congress regarding the execution-style murders of United States citizens Ylli, Agron, and Mehmet Bytyqi in the Republic of Serbia in July 1999. (Pending is the vote on the motion to suspend the rules and agree.)
H. Res. 892 June 21	A resolution calling on the Government of the Republic of Rwanda to release Paul Rusesabagina on humanitarian grounds. (Pending is the vote on the motion to suspend the rules and agree, as amended.)
H.R. 7337 July 12	A bill to require the Archivist of the United States to submit a plan to Congress to eliminate the records backlog at the National Personnel Records Center, and for other purposes. (Pending is the vote on the motion to suspend the rules and pass, as amended.)
H.R. 203 July 12	A bill to designate the facility of the United States Postal Service located at 4020 Broadway Street in Houston, Texas, as the "Benny C. Martinez Post Office Building". (Pending is the vote on the motion to suspend the rules and pass.)
H.R. 5659 July 12	A bill to designate the facility of the United States Postal Service located at 1961 North C Street in Oxnard, California, as the "John R. Hatcher III Post Office Building". (Pending is the vote on the motion to suspend the rules and pass.)

THE MORNING HOUR FOR THE CALL OF COMMITTEES

Rule XIV, clause 4:

"4. After the unfinished business has been disposed of, the Speaker shall call each standing committee in regular order and then select committees. Each committee when named may call up for consideration a bill or resolution reported by it on a previous day and on the House Calendar. If the Speaker does not complete the call of the committees before the House passes to other business, the next call shall resume at the point it left off, giving preference to the last bill or resolution under consideration. A committee that has occupied the call for two days may not call up another bill or resolution until the other committees have been called in their turn."

NOTE.—Call rests with the Committee on Agriculture.

CALENDAR WEDNESDAY BUSINESS

Rule XV, clause 6:

"6. (a) On Wednesday of each week, business shall not be in order before completion of the call of those committees (except as provided by clause 4 of rule XIV) whose chair, or other member authorized by the committee, has announced to the House a request for such call on the preceding legislative day.

(b) A bill or resolution on either the House or the Union Calendar, except bills or resolutions that are privileged under the Rules of the House, may be called under this clause. A bill or resolution called up from the Union Calendar shall be considered in the Committee of the Whole House on the state of the Union without motion, subject to clause 3 of rule XVI. General debate on a measure considered under this clause shall be confined to the measure and may not exceed two hours equally divided between a proponent and an opponent.

(c) This clause does not apply during the last two weeks of a session of Congress.

(d) Precedents, rulings, or procedures in effect before the One Hundred Eleventh Congress regarding the priority of business and the availability of other business on Wednesday shall be applied only to the extent consistent with this clause."

NOTE.—Call rests with the Committee on Agriculture.

SPECIAL LEGISLATIVE DAYS

Calendar Wednesday	Wednesday of each week, when specifically noticed, except during the last 2 weeks of a session (clause 6, rule XV). Mondays of each month (clause 4, rule XV).
Private Calendar	First Tuesday of each month (clause 5, rule XV).
Suspension of rules	Mondays, Tuesdays and Wednesdays and during the last 6 days of a session (clause 1, rule XV).
