**UNANIMOUS CONSENT AGREEMENT**

## S. CON. RES. 5 (CALENDAR NO. 4)

1.—*Ordered*, That on Thursday, February 4, 2021, upon the conclusion of Morning Business, the Senate resume consideration of S. Con. Res. 5, a resolution setting forth the congressional budget for the United States Government for fiscal year 2021 and setting forth the appropriate budgetary levels for fiscal years 2022 through 2030; provided, that the time from 2:00 p.m. until 2:30 p.m. be equally divided between the Senator from South Carolina (Mr. Graham) and the Senator from Vermont (Mr. Sanders); provided further, that following their remarks, all time on the budget resolution be considered expired. (*February 3, 2021.*)

 "And in all cases of conference asked after a vote of disagreement, etc., the conferees of the House asking it are to leave the papers with the conferees of the other \* \* \*." The House agreeing to the conference usually acts on the report before the House requesting a conference.
