UNANIMOUS CONSENT AGREEMENT**S. 914 (ORDER NO. 34)**

1.—*Ordered*, That on Thursday, April 29, 2021, upon the conclusion of Morning Business, the Senate resume consideration of S. 914, a bill to amend the Safe Drinking Water Act and the Federal Water Pollution Control Act to reauthorize programs under those Acts, and for other purposes; provided, that the following amendments be reported by number and be the only amendments in order:

Rubio-Scott (FL) Amdt. No. 1471, as modified;

Shaheen Amdt. No. 1461;

Kennedy Amdt. No. 1469; and

Lee Amdt. No. 1472; provided further, that at 11:30 a.m., the Senate vote in relation to the amendments in the order listed; further, that 60-affirmative votes be required for adoption of the Lee amendment and passage of the bill; provided further, that upon the disposition of the amendments, Amdt. No. 1460, offered by the Senator from Illinois (Ms. Duckworth), as amended, if amended, be agreed to; further, that the bill be considered read a third time; provided further, that at 1:45 p.m., the Senate vote on passage of the bill, as amended, with two minutes of debate, equally divided prior to each vote; further, that the motions to reconsider be considered made and laid upon the table, all with no intervening action or debate.
