**UNANIMOUS CONSENT AGREEMENT**

## S. 1260 (ORDER NO. 58)

1.—*Ordered*, That on Thursday, May 20, 2021, upon the conclusion of Morning Business, the Senate resume consideration of S. 1260, a bill to establish a new Directorate for Technology and Innovation in the National Science Foundation, to establish a regional technology hub program, to require a strategy and report on economic security, science, research, innovation, manufacturing, and job creation, to establish a critical supply chain resiliency program, and for other purposes; provided, that Amdt. No. 1523, to be offered by the Senator from Oklahoma (Mr. Inhofe) and the Senator from Alabama (Mr. Shelby), and Amdt. No. 1518, to be offered by the Senator from Wisconsin (Mr. Johnson) be called up and reported by number; provided further, that at 12:00 noon the Senate vote in relation to Amdt. No. 1523; and at 1:30 p.m. vote in relation to Amdt. No. 1518; provided further, that no amendments be in order to either amendment before the vote and that each amendment be subject to a 60-affirmative vote threshold. (*May 19, 2021.*)

## H.R. 1318

2.—*Ordered*, That if the Senate receives a message from the House of Representatives that the House has passed H.R. 1318, a bill to restrict the imposition by the Secretary of Homeland Security of fines, penalties, duties, or tariffs applicable only to coastwise voyages, or prohibit otherwise qualified non-United States citizens from serving as crew, on specified vessels transporting passengers between the State of Washington and the State of Alaska, to address a Canadian cruise ship ban and the extraordinary impacts of the COVID-19 pandemic on Alaskan communities, and for other purposes, and the text is identical to S. 593, as passed by the Senate, the bill be considered read three times and passed; provided, that the motion to reconsider be considered made and laid upon the table, with no intervening action or debate. (*May 19, 2021.*)
