UNANIMOUS CONSENT AGREEMENT

S. 1260 (ORDER NO. 58)

1.—*Ordered*, That with respect to S. 1260, a bill to establish a new Directorate for Technology and Innovation in the National Science Foundation, to establish a regional technology hub program, to require a strategy and report on economic security, science, research, innovation, manufacturing, and job creation, to establish a critical supply chain resiliency program, and for other purposes, all time during recess count post-cloture on Amdt. No. 1502, offered by the Senator from New York (Mr. Schumer); provided, that the filing deadline for first degree amendments be 2:30 p.m. on Wednesday, May 26, 2021; provided further, that the filing deadline for second degree amendments be 10:30 a.m. on Thursday, May 27, 2021; further, that with respect to the motion to invoke cloture on S. 1260, the mandatory quorum call under Rule XXII be waived. (*May 25, 26, 28 2021.*)

H.R. 3233 (ORDER NO. 60)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 3233, an Act to establish the National Commission to Investigate the January 6 Attack on the United States Capitol Complex, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*May 25, 2021.*)
