**UNANIMOUS CONSENT AGREEMENT**

## S. 1260 (ORDER NO. 58)

1.—*Ordered*, That on Tuesday, June 8, 2021, following the disposition of the Rodriguez nomination, the Senate resume consideration of S. 1260, a bill to establish a new Directorate for Technology and Innovation in the National Science Foundation, to establish a regional technology hub program, to require a strategy and report on economic security, science, research, innovation, manufacturing, and job creation, to establish a critical supply chain resiliency program, and for other purposes; provided, that all post-cloture time be considered expired, and the Senate vote in relation to Amdt. No. 1858, offered by the Senator from Texas (Mr. Cornyn); provided further, that if a Budget Act point of order is raised and a motion to waive is made following the disposition of the Cornyn amendment, the Senate vote on the motion to waive; further, that if waived, the Senate vote on Amdt. No. 1502, offered by the Senator from New York (Mr. Schumer), as amended; provided further, that the cloture motion with respect to S. 1260 be withdrawn; further, that the bill be considered read a third time, and the Senate vote on passage of the bill, as amended, if amended, with 60-affirmative votes required for passage, all with no intervening action or debate; further, that the filing deadline for first degree amendments be 2:30 p.m. on Wednesday, May 26, 2021; provided further, that the filing deadline for second degree amendments be 10:30 a.m. on Thursday, May 27, 2021. (*May 25, 26, 28, June 7, 2021.*)

## H.R. 7 (ORDER NO. 46)

2.—*Ordered*, That the motion to invoke cloture on the motion to proceed to H.R. 7, an Act to amend the Fair Labor Standards Act of 1938 to provide more effective remedies to victims of discrimination in the payment of wages on the basis of sex, and for other purposes, ripen following the disposition of S. 1260; provided further, that the mandatory quorum call under Rule XXII be waived. (*May 28, 2021.*)
