UNANIMOUS CONSENT AGREEMENT

H.R. 1652

1.—*Ordered*, That at a time to be determined by the Majority Leader, in consultation with the Republican Leader, the Senate proceed to the immediate consideration of H.R. 1652, an Act to deposit certain funds into the Crime Victims Fund, to waive matching requirements, and for other purposes, which was received from the House; provided, that the only amendment in order be Amdt. No. 2121, to be offered by the Senator from Pennsylvania (Mr. Toomey); provided further, that there be two hours for debate, equally divided between the Leaders or their designees and that upon the use or yielding back of that time, the Senate vote in relation to the Toomey amendment; further, that upon the disposition of the Toomey amendment, the bill as amended, if amended, be considered read a third time and the Senate vote on passage of the bill, with a 60 affirmative vote threshold required for passage; provided further, that there be two minutes of debate equally divided prior to each vote; further, that the motions to reconsider be considered made and laid upon the table, with no intervening action or debate.
