UNANIMOUS CONSENT AGREEMENT

H.R. 3684 (CALENDAR NO. 100)

Ordered, That on Sunday, August 8, 2021, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 3684, an Act to authorize funds for Federal-aid highways, highway safety programs, and transit programs, and for other purposes; provided, that the filing deadline for first degree amendments be 11:15 a.m. on Saturday and the filing deadline for second degree amendments be 11:45 a.m.; provided further, that with respect to the cloture motion filed on Thursday, August 5, the mandatory quorum call under Rule XXII be waived; further, that all time during recess, adjournment, or period of Morning Business count post-cloture. (*Aug. 5, 6, 7, 2021.*)
