**UNANIMOUS CONSENT AGREEMENT**

S. 2093 (ORDER NO. 77)

*Ordered*, That with respect to the cloture motion on the motion to proceed to S. 2093, a bill to expand Americans' access to the ballot box, reduce the influence of big money in politics, strengthen ethics rules for public servants, and implement other anti-corruption measures for the purpose of fortifying our democracy, and for other purposes, the cloture motion ripen at 5:30 p.m. on Monday, September 13, 2021; provided, that the mandatory quorum call under Rule XXII be waived. (*Aug. 11, 2021.*)
