UNANIMOUS CONSENT AGREEMENT

S. 4 (ORDER NO. 143)

1.—*Ordered*, That on Wednesday, November 3, 2021, the motion to invoke cloture on the motion to proceed to S. 4, a bill to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, ripen at 2:15 p.m., notwithstanding the provisions of Rule XXII; provided, that the mandatory quorum call under Rule XXII be waived. (*Nov. 1, 2, 2021.*)

S. 2747 (ORDER NO. 125)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2747, a bill to expand Americans' access to the ballot box and reduce the influence of big money in politics, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 18, 2021.*)

When objection is heard to immediate consideration of a resolution or motion when submitted, it shall be placed here, to be laid before the Senate on the next legislative day for consideration, unless by unanimous consent the Senate shall otherwise direct. (Rule XIV, Paragraph 6.)
