## UNANIMOUS CONSENT AGREEMENTS

## H.R. 3076 (ORDER NO. 266)

1.—*Ordered*, That on Wednesday, March 2, 2022, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 3076, an Act to provide stability to and enhance the services of the United States Postal Service, and for other purposes. (*Mar. 1, 2022.*)

## S.J. RES. 32 (ORDER NO. 291)

2.—*Ordered*, That on Wednesday, March 2, 2022, at 12:00 noon, the Senate proceed to the consideration of S.J. Res. 32, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Centers for Medicare & Medicaid Services relating to “Medicare and Medicaid Programs; Omnibus COVID–19 Health Care Staff Vaccination”; provided, that the time until 2:30 p.m. be equally divided between the Leaders or their designees; provided further, that upon the use or yielding back of that time, the joint resolution be read a third time and the Senate vote on the resolution. (*Mar. 1, 2022.*)

## HOUSE MESSAGE TO ACCOMPANY H.R. 5746

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to the Senate amendment to H.R. 5746, an Act to amend title 51, United States Code, to extend the authority of the National Aeronautics and Space Administration to enter into leases of non-excess property of the Administration, the mandatory quorum call under Rule XXII be waived. (*Jan. 19, 2022.*)

## H.R. 4350 (ORDER NO. 144)

4.—*Ordered*, That with respect to H.R. 4350, a bill to authorize appropriations for fiscal year 2022 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the cloture motion with respect to H.R. 4350 ripen following the disposition of Amdt. No. 3867, as modified; provided further, that the filing deadline for first degree amendments to Amdt. No. 3867, as modified, and H.R. 4350 be at 3:30 p.m. on Monday, November 29, 2021; further, that with respect to the motions to invoke cloture on Amdt. No. 3867, as modified, and H.R. 4350, the mandatory quorum calls under Rule XXII be waived. (*Nov. 19, 29, 2021.*)

## S. 4 (ORDER NO. 143)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4, a bill to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Nov. 1, 2021.*)

## S. 2747 (ORDER NO. 125)

6.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2747, a bill to expand Americans’ access to the ballot box and reduce the influence of big money in politics, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 18, 2021.*)
