UNANIMOUS CONSENT AGREEMENTS**H.R. 4521 (ORDER NO. 282)**

1.—*Ordered*, That on Tuesday, March 22, 2022, upon the conclusion of Morning Business, the Senate resume consideration of the motion to proceed to H.R. 4521, an Act to provide for a coordinated Federal research initiative to ensure continued United States leadership in engineering biology; provided, that all time during adjournment, recess, Leader remarks, and Morning Business count post-cloture. (*Mar. 21, 2022.*)

HOUSE MESSAGE TO ACCOMPANY H.R. 5746

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to the Senate amendment to H.R. 5746, an Act to amend title 51, United States Code, to extend the authority of the National Aeronautics and Space Administration to enter into leases of non-excess property of the Administration, the mandatory quorum call under Rule XXII be waived. (*Jan. 19, 2022.*)

H.R. 4350 (ORDER NO. 144)

3.—*Ordered*, That with respect to H.R. 4350, a bill to authorize appropriations for fiscal year 2022 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the cloture motion with respect to H.R. 4350 ripen following the disposition of Amdt. No. 3867, as modified; provided further, that the filing deadline for first degree amendments to Amdt. No. 3867, as modified, and H.R. 4350 be at 3:30 p.m. on Monday, November 29, 2021; further, that with respect to the motions to invoke cloture on Amdt. No. 3867, as modified, and H.R. 4350, the mandatory quorum calls under Rule XXII be waived. (*Nov. 19, 29, 2021.*)

S. 4 (ORDER NO. 143)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4, a bill to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Nov. 1, 2021.*)

S. 2747 (ORDER NO. 125)

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2747, a bill to expand Americans' access to the ballot box and reduce the influence of big money in politics, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 18, 2021.*)

When objection is heard to the second reading of a bill or joint resolution, that measure is then laid before the Senate during morning business of the next legislative day for the second reading. (Rule XIV, Paragraph 2.)

MOTIONS FOR RECONSIDERATION

After an action taken by the Senate, any Senator voting with the prevailing side or who has not voted may, on the same day or on either of the next two days of actual session thereafter, either enter a motion for reconsideration or move a reconsideration. This section contains such motions not yet acted on as so provided by Rule XIII, Paragraph 1.
