## UNANIMOUS CONSENT AGREEMENTS

## HOUSE MESSAGE TO ACCOMPANY S. 3373

1.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to S. 3373, an Act to improve the Iraq and Afghanistan Service Grant and the Children of Fallen Heroes Grant, the mandatory quorum call under Rule XXII be waived. (*July 25, 2022.*)

## H.R. 7776 (ORDER NO. 399)

2.—*Ordered*, That at a time to be determined by the Majority Leader, following consultation with the Republican Leader, the Senate proceed to the consideration of H.R. 7776, an Act to provide for improvements to the rivers and harbors of the United States, to provide for the conservation and development of water and related resources, and for other purposes; provided, that the Carper-Capito-Cardin-Cramer substitute, Amdt. No. 5140, be considered and agreed to; provided further, that there be up to one hour of debate, equally divided in the usual form; further, that upon the use or yielding back of that time, if a Budget point or order is made and a motion to waive is made, the Senate vote on the motion to waive; provided further, that if the point of order is waived, the bill, as amended, be considered read a third time and the Senate vote on passage of the bill, with 60 affirmative votes required for passage; further, that the motions to reconsider be considered made and laid upon the table. (*July 20, 2022.*)

## H.R. 350 (ORDER NO. 371)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 350, an Act to authorize dedicated domestic terrorism offices within the Department of Homeland Security, the Department of Justice, and the Federal Bureau of Investigation to analyze and monitor domestic terrorist activity and require the Federal Government to take steps to prevent domestic terrorism, the mandatory quorum call under Rule XXII be waived. (*May 24, 2022.*)

## H.R. 4373 (ORDER NO. 310)

4.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to H.R. 4373, an Act making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2022, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Mar. 29, 2022.*)

## HOUSE MESSAGE TO ACCOMPANY H.R. 5746

5.—*Ordered*, That with respect to the motion to invoke cloture on the motion to concur in the House amendment to the Senate amendment to H.R. 5746, an Act to amend title 51, United States Code, to extend the authority of the National Aeronautics and Space Administration to enter into leases of non-excess property of the Administration, the mandatory quorum call under Rule XXII be waived. (*Jan. 19, 2022.*)

## H.R. 4350 (ORDER NO. 144)

6.—*Ordered*, That with respect to H.R. 4350, a bill to authorize appropriations for fiscal year 2022 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes, the cloture motion with respect to H.R. 4350 ripen following the disposition of Amdt. No. 3867, as modified; provided further, that the filing deadline for first degree amendments to Amdt. No. 3867, as modified, and H.R. 4350 be at 3:30 p.m. on Monday, November 29, 2021; further, that with respect to the motions to invoke cloture on Amdt. No. 3867, as modified, and H.R. 4350, the mandatory quorum calls under Rule XXII be waived. (*Nov. 19, 29, 2021.*)

## S. 4 (ORDER NO. 143)

7.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 4, a bill to amend the Voting Rights Act of 1965 to revise the criteria for determining which States and political subdivisions are subject to section 4 of the Act, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Nov. 1, 2021.*)

## S. 2747 (ORDER NO. 125)

8.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 2747, a bill to expand Americans' access to the ballot box and reduce the influence of big money in politics, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*Oct. 18, 2021.*)
