UNANIMOUS CONSENT AGREEMENTS

S.J. RES. 9 AND H.J. RES. 39

1.—*Ordered*, That on Wednesday, May 3, 2023, following the cloture vote on the Hsu nomination, notwithstanding Rule XXII, the Senate resume Legislative Session and the Committee on Environment and Public Works be discharged from further consideration of S.J. Res. 9, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the United States Fish and Wildlife Service relating to “Endangered and Threatened Wildlife and Plants; Lesser Prairie-Chicken; Threatened Status With Section 4(d) Rule for the Northern Distinct Population Segment and Endangered Status for the Southern Distinct Population Segment”; provided, that the Senate proceed to the en bloc consideration of H.J. Res. 39, a joint resolution disapproving the rule submitted by the Department of Commerce relating to “Procedures Covering Suspension of Liquidation, Duties and Estimated Duties in Accord With Presidential Proclamation 10414”, which was received from the House, and S.J. Res. 9; provided further, that at 6:15 p.m., the joint resolutions be considered read a third time and the Senate vote on passage of the joint resolutions in the order listed, with 15 minutes for debate, equally divided between the two Leaders or their designees, between the votes on the joint resolutions. (*May 2, 2023.*)

S.J. RES. 4 (ORDER NO. 3)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

S. 326 (ORDER NO. 32)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
