**UNANIMOUS CONSENT AGREEMENTS**

## H.J. RES. 42

1.—*Ordered*, That on Tuesday, May 16, 2023, upon the conclusion of Morning Business, the Senate proceed to the consideration of H.J. Res. 42, a joint resolution disapproving the action of the District of Columbia Council in approving the Comprehensive Policing and Justice Reform Amendment Act of 2022; provided, that at 2:30 p.m., the joint resolution be considered read a third time and the Senate vote on passage of the joint resolution. (*May 15, 2023.*)

## S.J. RES. 4 (ORDER NO. 3)

2.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (*April 25, 2023.*)

## S. 326 (ORDER NO. 32)

3.—*Ordered*, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived. (*April 20, 2023.*)
