UNANIMOUS CONSENT AGREEMENTS

S. 2226 (ORDER NO. 119)

1.—Ordered, That on Thursday, July 27, 2023, upon the conclusion of Morning Business, the Senate resume consideration of S. 2226, a bill to authorize appropriations for fiscal year 2024 for military activities of the Department of Defense, for military construction, and for defense activities of the Department of Energy, to prescribe military personnel strengths for such fiscal year, and for other purposes; provided, that it be in order to call up the following amendments:

No. 935, offered by the Senator from New York (Mr. Schumer), and S. 2226, the mandatory quorum calls under Rule XXII be waived. (July 26, 27, 2023.)


