UNANIMOUS CONSENT AGREEMENTS

H.R. 815 (ORDER NO. 30)

1.—Ordered, That on Monday, November 13, 2023, the motion to invoke cloture on the motion to proceed to H.R. 815, an Act to amend title 38, United States Code, to make certain improvements relating to the eligibility of veterans to receive reimbursement for emergency treatment furnished through the Veterans Community Care program, and for other purposes, ripen at 5:30 p.m.; provided, that the mandatory quorum call under Rule XXII be waived. 2.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S.J. Res. 4, a joint resolution removing the deadline for the ratification of the Equal Rights Amendment, the mandatory quorum call under Rule XXII be waived. (April 25, 2023.)

3.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived.
