UNANIMOUS CONSENT AGREEMENTS

H.R. 2872 (ORDER NO. 243)

1.—Ordered, That on Thursday, January 18, 2024, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 2872, an Act to amend the Permanent Electronic Duck Stamp Act of 2013 to allow the Secretary of the Interior to issue electronic stamps under such Act, and for other purposes; provided, that the only amendments and motions in order to the bill be the following:

Amdt. No. 1384—(Mr. Paul)

Motion to Recommit—(Mr. Marshall)

Amdt. No. 1382—(Mr. Braun)
Amdt. No. 1381—Mr. Schumer (for Mrs. Murray);
Provided further, That at 12:30 p.m., on Thursday, January 18, the Senate vote on the adoption of each of the amendments and motion in the order listed, with each subject to 60 affirmative votes required for adoption, with the exception of the Marshall motion and the Schumer for Murray amendment #1381; further, that there be 2 minutes of debate, equally divided, prior to each vote.

Ordered further, That upon disposition of the Braun amendment, the Murray substitute amendment as amended, if amended, be agreed to, the bill be considered read a third time and the Senate vote on passage of the bill, as amended, if amended with 60 affirmative votes required for passage, all without further intervening action or debate. S.J. RES. 50

2.—Ordered, That notwithstanding Rule XXII and 5 U.S.C. §802, at a time to be determined by the Majority Leader in consultation with the Republican Leader, no later than January 31, 2024, if S.J. Res. 50, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Securities and Exchange Commission relating to "Cybersecurity Risk Management, Strategy, Governance, and Incident Disclosure", is discharged from the Committee on Banking, Housing, and Urban Affairs, it be in order for the Senator from North Carolina (Mr. Tillis) or his designee to move to proceed to the consideration of S.J. Res. 50; provided, that if the motion to proceed is agreed to, there be 10 hours for debate equally divided between the proponents and opponents of the joint resolution; provided further, that upon the use or yielding back of that time, the joint resolution be read a third time and the Senate vote on passage of the joint resolution; further, that all other provisions under chapter 8 of title 5, United States Code, remain in effect except the 60 session day clock. (December 20, 2023.)

4.—Ordered, That with respect to the motion to invoke cloture on the motion to proceed to S. 326, a bill to direct the Secretary of Veterans Affairs to carry out a study and clinical trials on the effects of cannabis on certain health outcomes of veterans with chronic pain and post-traumatic stress disorder, and for other purposes, the mandatory quorum call under Rule XXII be waived.
