S.J. RES. 38

2.—Ordered, That the veto message with respect to S.J. Res. 38, a joint resolution providing for congressional disapproval under chapter 8 of title 5, United States Code, of the rule submitted by the Federal Highway Administration relating to "Waiver of Buy America Requirements for Electric Vehicle Chargers", be considered at a time to be determined by the Majority Leader in concurrence with the Republican Leader prior to February 29, 2024, notwithstanding Rule XXII; provided, that there be up to 2 hours for debate equally divided between the two Leaders or their designees and the Senate vote on passage of the joint resolution, the objections of the President to the contrary notwithstanding.
